#### **COUNCIL MEETING INFORMATION NOTES**

- 1. Your Council generally handles all business at Ordinary or Special Council Meetings.
- 2. From time to time Council may form a Committee to examine subjects and then report to Council.
- Generally all meetings are open to the public; however, from time to time Council will be required to deal
  with personal, legal and other sensitive matters. On those occasions Council will generally close that part
  of the meeting to the public. Every endeavour will be made to do this as the last item of business of the
  meeting.
- 4. Public Question Time. It is a requirement of the Local Government Act 1995 to allow at least fifteen (15) minutes for public question time following the opening and announcements at the beginning of the meeting. Should there be a series of questions the period can be extended at the discretion of the Chairman.

Written notice of each question should be given to the Chief Executive Officer prior to 2:30pm on the day of the meeting. A summary of each question and response is included in the Minutes.

When a question is not able to be answered at the Council Meeting a written answer will be provided after the necessary research has been carried out. Council staff will endeavour to provide the answers prior to the next meeting of Council.

- 5. Councillors may from time to time have a financial interest in a matter before Council. Councillors must declare an interest and the extent of the interest in the matter on the Agenda. However, the Councillor can request the meeting to declare the matter trivial, insignificant or in common with a significant number of electors or ratepayers. The Councillor must leave the meeting whilst the matter is discussed and cannot vote unless those present agree as above.
  - **Members of staff,** who have delegated authority from Council to act on certain matters, may from time to time have a financial interest in a matter on the Agenda. The member of staff must declare that interest and generally the Chairman of the meeting will advise the Officer if he/she is to leave the meeting.
- 6. Agendas including an Information Bulletin are delivered to Councillors within the requirements of the Local Government Act 1995, i.e. seventy-two (72) hours prior to the advertised commencement of the meeting. Whilst late items are generally not considered there is provision on the Agenda for items of an urgent nature to be considered.

Should an elector wish to have a matter placed on the Agenda the relevant information should be forwarded to the Chief Executive Officer in time to allow the matter to be fully researched by staff. An Agenda item including a recommendation will then be submitted to Council for consideration.

The Agenda closes the Monday week prior to the Council Meeting (i.e. ten (10) days prior to the meeting).

The Information Bulletin produced as part of the Agenda includes items of interest and information, which does not require a decision of Council.

- 7. Agendas for Ordinary Meetings are available in the Coolgardie and Kambalda Offices/Libraries seventy-two (72) hours prior to the meeting and the public are invited to secure a copy.
- 8. Agenda items submitted to Council will include a recommendation for Council consideration. Electors should not interpret and/or act on the recommendations until after they have been considered by Council. Please note the Disclaimer in the Agenda (page 3).
- 9. Public Question Time Statutory Provisions Local Government Act 1995

Time is to be allocated for questions to be raised by members of the public and responded to at:

- (a) Every ordinary meeting of a council; and
- (b) Such other meetings of councils or committees as may be prescribed

Procedures and the minimum time to be allocated for the asking of and responding to questions raised by members of the public at council or committee meetings are to be in accordance with regulations.

9A. Question Time for the Public at Certain Meetings – s5.24 (1) (b)

# Local Government (Administration) Regulations 1996

- Reg 5 For the purpose of section 5.24(1)(b), the meetings at which time is to be allocated for questions to be raised by members of the public and responded to are:
  - (a) every special meeting of a council; and
  - (b) every meeting of a committee to which the local government has delegated a power or duty.

# Minimum Question Time for the Public - s5.24 (2)

- Reg 6 (1) The minimum time to be allocated for the asking of and responding to questions raised by members of the public at ordinary meetings of councils and meetings referred to in regulation 5 is fifteen (15) minutes.
  - Once all the questions raised by members of the public have been asked and responded to at a meeting referred to in sub regulation (1), nothing in these regulations prevents the unused part of the minimum question time period from being used for other matters.

Procedures for Question Time for the Public – s5.24 (2)

#### Local Government (Administration) Regulations 1996

- Reg 7 (1) Procedures for the asking of and responding to questions raised by members of the public at a meeting referred to in regulation 6 (1) are to be determined:
  - (a) by the person presiding at the meeting; or
  - (b) in the case where the majority of members of the council or committee present at the meeting disagree with the person presiding, by the majority of members,

having regard to the requirements of sub regulations (2) and (3).

- (2) The time allocated to the asking and responding to questions raised by members of the public at a meeting referred to in regulation 6(1) is to precede the discussion of any matter that requires a decision to be made by the council or the committee, as the case may be.
- (3) Each member of the public who wishes to ask a question at a meeting referred to in regulation 6(1) is to be given an equal and fair opportunity to ask the question and receive a response.
- (4) Nothing in sub regulation (3) requires:
  - (a) A council to answer a question that does not relate to a matter affecting the local government;
  - (b) A council at a special meeting to answer a question that does not relate to the purpose of the meeting; or
  - (c) A committee to answer a question that does not relate to a function of the committee.

# 2. Public Inspection of Unconfirmed Minutes (Reg 13)

A copy of the unconfirmed Minutes of Ordinary and Special Meetings will be available for public inspection in the Coolgardie and Kambalda Offices/Libraries within ten (10) working days after the Meeting.

# NOTE:

#### 10.3 Unopposed Business

- (1) Upon a motion being moved and seconded, the person presiding may ask the meeting if any member opposes it.
- (2) If no member signifies opposition to the motion the person presiding may declare the motion in sub clause (1) carried without debate and without taking a vote on it,
- (3) A motion carried under sub clause (2) is to be recorded in the minutes as a unanimous decision of the Council or committee.
- (4) If a member signifies opposition to a motion the motion is to be dealt with according to this Part.
- (5) This clause does not apply to any motion or decision to revoke or change a decision which has been made at a Council or committee meeting.

1. As Council represent the Community and the CEO's proposed Cambodia trip is to "continue" the momentum generated from the previous forum on "Establishing the Coolgardie Green Mining Circular Economy Hub" and there has been no report, nor an analysis of its benefit to the Shire, how then can Council support another forum without tangible benefits, especially at cost of \$45,000 to develop material for it?

Council has not supported the CEOs Cambodia trip.

2. The \$1M loan (25 Oct) was to be a 5yr loan @ 5.50%, now it is a 10 year loan at 5.56% and as the supposed rent won't cover the loan, nor interest, nor the extra \$80,000 from Reserves, where will the extra money be coming from?

Revenue will come from Mining companies who will be paying a per night rent.

3. As generators are running in the middle of town and with the proposed expansion and more larger transport to the middle of town, how does this promote a "Greener Environment"?

The generators are fuel efficient and guiet and will not impact noise abatement regulations.

4. Please define what constitutes a casual single village room rate (\$165/night) as opposed to the single village room rate \$150/night?

The casual room rate is for casual room hire whereas the single rate is for longer term hire arrangements.

5. Is there a normal Executive Village Room rate or is the rate for an executive room only rented on a casual basis, \$225/night?

On a casual basis or as per agreement with the CEO

6. How many of the executive rooms are there or will there be in the camp?

Eight (8)

7. Do there rooms constitute the camp expansion?

It is within the original village footprint.

8. Since the Bluebush Village Agreement Item 11.1 is CONFIDENTIAL, will the rates changed to mining companies be lower than the advertised rate or will they be as advertised as the Community is aware of the substantial profit promised from the operation of the camp?

#### SUMMARY

The CEO seeks Council approval of travel by the CEO to attend as a keynote presenter at the 11<sup>th</sup> Regional 3R and Circular Economy Forum in Asia and the Pacific in Cambodia on the 8<sup>th</sup> – 10<sup>th</sup> February 2023.

#### **BACKGROUND**

The Shire has been collaborating with Circular Economy Alliance Australia (CEAA) on the development of the proposed Coolgardie Regional Transformational Alliance (CRTA). Over the last 18 months CEAA and the Shire have been strategizing the best platform for positioning Coolgardie on the world stage and leveraging/collaborating with multiple sectors for Circular Economy, ESG, Climate change outcomes that also regional transformation.

On the 29 October 2021 Council listened to an online presentation by CEAA and the Shire of Coolgardie CEO, to the 16<sup>th</sup> Annual Session of the Global Forum on Human Settlements that had a theme "Accelerate Green Transformation and Innovation towards Healthy, Resilient & Carbon-neutral Cities". The CEAA and the Shire spoke to a global audience on the subject "Establishing the Coolgardie Green Mining Circular Economy Hub".

Heads and senior leaders of top organisations participated in this Global Forum such as:

- World Wildlife Fund (WWF), World Meteorological Organization (WMO), United Nations Conference on Trade and Development (UNCTAD) United Nations Centre for Regional Development (UNCRD) Global Green Growth Institute (GGGI)
- United Nations Development Programme (UNDP)
- Asian Development Bank (ADB) African Development Bank (AfDB)
- United Nations Economic and Social Commission in Asia and the Pacific (UNESCAP) United Nations Economic Commission for Africa (UNECA)
- United Nations Office for Disaster Risk Reduction (UNDRR)
- United Nations Industrial Development Organization (UNIDO)
- United Nations Convention on Biological Diversity (UNCBD)
- UNEP Finance Initiative (UNEP-FI) Swedish Energy Agency (SEA) International Union for Conservation of Nature (IUCN)
- World Ocean Council (WOC), Universal Peace Federation (UPF)
- World Association of Non-Governmental Organizations (WANGO)

The Shire used this platform to announce that it is working on developing a circular economy hub.

Attendance at the 11th Regional 3R and Circular Economy Forum in Cambodia will be the second time the Shire has spoken to a global audience and will be a continuum of the momentum generated from the 16th Annual Session of the Global Forum on Human Settlements.

#### COMMENT

The Shire has the unique opportunity to be seen as a leading example of how a regional body based in a remote location can lead and involve all sectors from government and mining industry to drive long term regional transformation.

The Shires aspiration is for the CRTA to take the opportunity that currently exists to show strong leadership and showcase what can be achieved through collaboration.

For example, partnering with CEAA has opened the opportunity for the Shire to be exposed to premiere agencies such as the World Bank, UN, IFC, Global Green Growth Institute, World Resources Institute, and many others.

Through this global recognition, the Shire has the opportunity to be recognised as a global hub, but this will require strong positioning of the Shire both nationally and internationally, building a strong narrative and creating a platform for multi sectoral collaboration. These measures will have the potential to unlock and leverage investments into the region.

Through its global contacts, CEAA has secured a keynote presentation slot at the 3R Asia Pacific Forum set for the 8<sup>th</sup> – 10<sup>th</sup> February 2023 in Cambodia. It is expected that government leaders from more than 35 countries will be attending.

In line with the MOU between the Shire and CEAA and the agreed objectives therein, CEAA has coordinated the proposed trip to Cambodia and secured the Shires presentation to a global audience.

In December 2021 Council endorsed an MOU with Circular Economy Alliance Australia. The key objectives of the MOU are:

- Support Coolgardie's Environment Social Governance (ESG) Framework
- Play a catalyst role for Economic Development
- Provide diverse employment opportunities for Indigenous communities
- Enable Climate change response and Environmental Improvement
- Provide a Social License to operate to the mining community
- Create a strong base for leveraging financial and intellectual capital.
- Achieve United Nations Sustainability Development Goals (SDG's)
- Achieve better coordination and collaboration between government,
- industry, community
- Promote regional achievements and become a focal point for engaging
- nationally and internationally
- Put Coolgardie on the world map creating greater opportunities
- Build a strong, engaged, sustainable and socially responsible community

Furthermore, key activities identified in the MOU are;

- Awareness Building and Strategic Planning Undertake presentations / conduct workshop with the Councillors and senior management
- Planning and Organisation Develop a high-level Project plan.
- Stakeholder Engagement and Partnerships Undertake a systematic stakeholder engagement process involving the industry, mining, community, and academic sectors. Do presentations and roundtables.
- Undertake capacity and awareness building masterclass.

- Communication, Promotion, and Information Brochures Prepare relevant promotion and information brochures. Prepare a brochure outlining the Shire of Coolgardie's vision and strategy for establishing the Green Mining Circular Economy Hub.
- Establish commitment from all stakeholders to establish the hub
- Prepare the Constitution and Charter
- Establish Funding / Partnership Arrangements with partners
- International Launch Launch the Hub at a major UN event
- Set up the Governance Structure and Board
- Appoint an Executive Officer and administration officer
- Prepare Business Plan for the Hub

The attendance of the CEO at the conference is consistent with one of the key activities highlighted above.

#### FINANCIAL IMPLICATIONS

Forum coordination, keynote participation, CEAA support, travel and accommodation expenses are estimated at \$45,000 - \$50,000.

In the 2022/2023 Annual Budget an allocation of \$235,000 was included for ESG, Circular Economy, Socio Economic Assessment and Shire Initiatives. To date only \$115,000 has ben spent from this allocation.

In preparation for the UNCRD Event the following tasks will need to be undertaken;

#### **Key Tasks**

- 1.Liaise with UNCRD to finalise the topic of the keynote presentation, provide an overview on Coolgardie, highlight its strategic significance and its crucial role in building partnerships and in developing major projects.
- 2.Build a powerful narrative on key Coolgardie projects and initiatives (past, current and proposed). Prepare slides and brochure for the event.
- 3.Prepare a structure of the keynote presentation in a way that demonstrates broader application that cuts across countries. The presentation will need to expertly structured to demonstrate a futuristic, innovative and collaborative approach. Highlight role of innovative approach such as Coolgardie Regional Transformation Alliance.
- 4.Demonstrate a globalise vision Top leaders and decision makers from 35 Asia Pacific nations would be listening to the keynote presentation.

5. Promote Coolgardie's leadership and the UNCRD \event to a strong 16,000 plus global knowledge community built by CEAA.

6.Liaise with UNCRD to ensure that our presentation receives wide coverage and fits into the theme of the event

These tasks once completed will provide the Shire with ongoing promotion, marketing and advocacy information including a video and presentation to be used at a Local, State and Federal Level and links with the Community Strategic Plan just recently adopted and the Draft ESG Framework. It is estimated that these tasks will be approximately \$45,000 to be taken from the Circular Economy Budget Allocation

The estimated breakdown of the actual costs for the CEO trip would be;

- Accommodation \$895 4 nights conference being held at same place as accommodation
- Flights \$2,600

# Provisional Concept Note of 11th Regional 3R and Circular Economy Forum in Asia and the Pacific

1. DATE: 08-10 February 2023

2. VENUE: Sokha Siem Reap Resort and Convention Center, Siem Reap, Cambodia

3. **THEME:** Integrating Circular Economy in Major Development Sectors towards Achieving Zero Waste Societies and the SDGs

4. Format: Mostly physical participation (to some extent hybrid)

#### 5. BACKGROUND

Asia-Pacific has been the most dynamic region globally and most growth in resource use has been triggered by rapid urbanization and industrial transformation. The policy and scientific community in Asia and the Pacific have recognized the large challenges of resource supply security, increasing waste and pollution, climate change and increasing frequency and magnitude of natural disasters as critical constraints to future growth and rising material standards of living in the region.

The UN member countries are concurrently implementing a number of international agendas and agreements which are inter-linked and mutually reinforcing - such as the 2030 Agenda for Sustainable Development and the underlined SDGs, the Paris Agreement on Climate Change, the New Urban Agenda, the Addis Ababa Action Agenda (AAAA), the Nairobi Mandate, the Sendai Framework for Disaster Risk Reduction, the UN Decade on Ecosystem Restoration, among others. The 2030 Agenda for Sustainable Development and the SDGs, in particular, not only call for equitable economic growth, but also provide an important political and implementation framework to implement 3R and resource efficiency to achieve circular economic development – an alternative economic growth model which is not at the expense of finite natural resources and ecological assets, rather it is regenerative.

3R and circular economy not only provide an important basis in achieving the SDG 12 (sustainable consumption and production) but also meaningful synergies in combinedly achieving the other SDGs such as SDG 6 (clean water and sanitation), SDG 13 (combat climate change), SDG 11 (safe, resilient, sustainable cities and communities), and SDG 14 (life below water), among others.

11th Regional 3R and Circular Economy Forum in Asia and the Pacific, Kingdom of Cambodia

UNCRD's 3R and circular economy initiative brings both the policy and scientific community to convene on an annual basis the Regional 3R and Circular Economy Forum in Asia-Pacific to strengthen the science-policy interface in addressing 3R and resource efficiency as the basic for economic growth, pollution prevention and strengthening resilience of cities and communities, and after all, to achieve these international agendas and agreements. The adoption in 2015 of both the 2030 Agenda for Sustainable Development and the Paris Agreement on climate change established a foundation for the coherent implementation of climate action and sustainable development objectives across all levels and sectors<sup>1</sup>. Globally, the waste management sector accounts for some 3.5% of anthropogenic GHG emissions<sup>2</sup>. Many countries have adopted policies to reduce waste, recycle resources and secure landfills to reduce environmental and climate impacts. The United Nation's SDGs Report 2022<sup>3</sup> states that unsustainable patterns of consumption and production are the root causes of the three-fold global crises of climate change, biodiversity loss and pollution. Such crises, and the resulting of the environmental degradation, threaten human well-being and the achievement of the SDGs. The report also highlights the urgent action necessary to achieve the SDGs and make meaningful progress for the people and the planet by 2030.

The UNEA-5 (Fifth Session of the United Nations Environment Assembly)<sup>4</sup> with theme of "Strengthening Actions for Nature to Achieve the Sustainable Development Goals" also called for strengthened action to protect and restore nature and promote nature-based solutions to achieve the SDGs in its three complementary dimensions (social, economic and environmental). Similarly, the High-Level Political Forum (HLPF) 2022<sup>5</sup> focused on the impact of COVID-19 on the 2030 Agenda and actions to recover better while accelerating progress towards the Sustainable Development Goals. To this regard, there is a need for all the member countries and citizens to seize the opportunity to work together to improve resource efficiency, reduce waste and pollution and shape a new circular economy.

Starting from the 6<sup>th</sup> Regional 3R Forum in Maldives (2015), circular economy approach has been mainstreamed in the policy discussions among the member countries. The 99 private tourist resorts of Maldives by signing the "Declaration by Private Tourist Resorts in Maldives for the Promotion of 3Rs and Resource Efficiency Towards Protection of Local Environment and Marine Ecosystem" underpinned the importance of science-policy-business in advancing 3R as an economic industry<sup>6</sup>. In the 7<sup>th</sup> Regional 3R Forum in South Australia in November 2016, the member countries adopted Adelaide 3R Declaration towards the Promotion of Circular Economy in Achieving Resource Efficient Societies in Asia and the Pacific under the 2030 Agenda for Sustainable Development<sup>7</sup>. Furthermore, at the 8th Regional

3R Forum held in India in April 2018, the participating Mayors and local authorities signed the voluntary and good-will Indore 3R Declaration of Asian Mayors on Achieving Clean Water, Clean Land and Clean Air in Cities<sup>8</sup>. In the 9<sup>th</sup> Regional 3R Forum in Thailand in March 2019, the member countries and participating cities agreed the Bangkok 3R Declaration Towards Prevention of Plastic Waste Pollution through 3R and Circular Economy<sup>9</sup>. Furthermore, the 10<sup>th</sup> Regional 3R and Circular Economy Forum (Series of Webinars)<sup>10</sup> in November-December 2021, recognized the important role of eco-towns in advancing 3R and circular economy and highlighted the symbiotic material flow in eco-towns or eco-industrial parks as the basis for advancing 3R, resource efficiency and circular economy. Information presented at the annual Regional 3R and Circular Economy Forum shows that several member countries are already undertaking 3R policy implementation and activities under the framework of Hanoi 3R Goals (2013-2023)<sup>11</sup> that support the global agendas and agreements.

With the above background, Ministry of Environment, Kingdom of Cambodia, the Ministry of the Environment of the Government of Japan (MOEJ), and the United Nations Centre for Regional Development (UNCRD) of Division for Sustainable Development Goals (DSDG) / UN DESA is co-organized the 11th Regional 3R and Circular Economy Forum in Asia and the Pacific (Hybrid) on 8-10 February 2023 Kingdom of Cambodia with the theme of "Integrating Circular Economy in Major Development Sectors towards Achieving Zero Waste Societies and the SDGs". The 11<sup>th</sup> Forum will also provide an opportunity to discuss the on-going process of preparing the new declaration- 3<sup>rd</sup> Drafting committee meeting-cum-Experts Consultation on Pre-zero draft of new 3R and Circular Economy Declaration (2024-2034) and launch the pre-final version of 'The Second State of 3Rs in Asia and the Pacific-Advancing Circular Economy in Asia and the Pacific Towards Achieving the Sustainable Development Goals' Report.

# 6.8. Expenditure from municipal fund not included in annual budget

- (1) A local government is not to incur expenditure from its municipal fund for an additional purpose except where the expenditure
  - (a) is incurred in a financial year before the adoption of the annual budget by the local government; or
  - (b) is authorised in advance by resolution\*; or
  - (c) is authorised in advance by the mayor or president in an emergency.

#### 6.20. Power to borrow

- (1) Subject to this Act, a local government may
  - (a) borrow or re-borrow money; or
  - (b) obtain credit; or
  - (c) arrange for financial accommodation to be extended to the local government in ways additional to or other than borrowing money or obtaining credit,

to enable the local government to perform the functions and exercise the powers conferred on it under this Act or any other written law.

(2) Where, in any financial year, a local government proposes to exercise a power under subsection (1) (power to borrow) and details of that proposal have not been included in the annual budget for that financial year —

<sup>\*</sup> Absolute majority required.

- (a) unless the proposal is of a prescribed kind, the local government must give one month's local public notice of the proposal; and
- (b) the resolution to exercise that power is to be by absolute majority.
- (3) Where a local government has exercised a power to borrow and
  - (a) it does not wish to proceed with the performance of the function or the exercise of the power for which the power to borrow was exercised; or
  - (b) after having completed the performance of the function or the exercise of the power for which the power to borrow was exercised, any part of the money borrowed, credit obtained or financial accommodation arranged has not been expended or utilized,

the local government may resolve\* to expend the money or utilize the credit or financial accommodation for another purpose if one month's local public notice is given of the proposed change of purpose.

- \* Absolute majority required.
- (4) A local government is not required to give local public notice under subsection (3)
  - (a) where the change of purpose has been disclosed in the annual budget of the local government for the relevant financial year; or
  - (b) in such other circumstances as are prescribed.
- (5) A change of purpose referred to in subsection (3) is to be disclosed in the annual financial report for the year in which the change occurs.

#### POLICY IMPLICATIONS

Nil

#### FINANCIAL IMPLICATIONS

The proposed developments were not included as part of the Annual Budget adopted by Council in July 2022. In accordance with section 6.8 of the Local Government Act 1995 any expenditure must be authorised in advance by absolute majority.

The proposed development would be funded primarily by way of a \$1m loan from the Commonwealth Bank of Australia with the balance of funds to be transferred from the Infrastructure Reserve.

The terms of the loan agreement would be a fixed loan repaid over a 10-year term.

Indicative pricing based on a 10-year loan fixed at 5.68% would result in quarterly repayments of \$32,936 and total interest payable over the term of the loan of \$317,458.

It is anticipated that the cumulative rent for all 3 dwellings would be approximately \$1,200 week. Applying a 5% CPI incremental over a period of 10 years the rental return would be \$755,785.

# 6.8. Expenditure from municipal fund not included in annual budget

- (1) A local government is not to incur expenditure from its municipal fund for an additional purpose except where the expenditure

  - (c) is authorised in advance by the mayor or president in an emergency.

  - (b) obtain credit; or
  - (c) arrange for financial accommodation to be extended to the local government in ways additional to or other than borrowing money or obtaining credit,

to enable the local government to perform the functions and exercise the powers conferred on it under this Act or any other written law.

(2) Where, in any financial year, a local government proposes to exercise a power under subsection (1) (power to borrow) and details of that proposal have not been included in the annual budget for that financial year —

<sup>\*</sup> Absolute majority required.

- (a) unless the proposal is of a prescribed kind, the local government must give one month's local public notice of the proposal; and
- (b) the resolution to exercise that power is to be by absolute majority.
- (3) Where a local government has exercised a power to borrow and
  - (a) it does not wish to proceed with the performance of the function or the exercise of the power for which the power to borrow was exercised; or
  - (b) after having completed the performance of the function or the exercise of the power for which the power to borrow was exercised, any part of the money borrowed, credit obtained or financial accommodation arranged has not been expended or utilized,

the local government may resolve\* to expend the money or utilize the credit or financial accommodation for another purpose if one month's local public notice is given of the proposed change of purpose.

- \* Absolute majority required.
- (4) A local government is not required to give local public notice under subsection (3)
  - (a) where the change of purpose has been disclosed in the annual budget of the local government for the relevant financial year; or
  - (b) in such other circumstances as are prescribed.
- (5) A change of purpose referred to in subsection (3) is to be disclosed in the annual financial report for the year in which the change occurs.

#### FINANCIAL IMPLICATIONS

The proposed developments were not included as part of the Annual Budget adopted by Council in July 2022. In accordance with section 6.8 of the Local Government Act 1995 any expenditure must be authorised in advance by absolute majority.

The proposed development would be funded by a \$500,000 loan from the Commonwealth Bank of Australia. The terms of the agreement would be a fixed loan repaid over a 5-year term.

Indicative pricing based on a 5-year loan fixed at 5.07% would result in quarterly repayments of \$28,457 and total interest payable over the term of the loan of \$69,148.

Without applying any CPI incremental increases over a 5-year period and conservatively budgeting on a 50% occupancy for 200 nights at \$150 night the total rental over a period of 5 years would be \$600,000.
