## SUMMARY

This item is presented for Council to accept the resignation of Mr James Trail as the Chief Executive Officer of the Shire of Coolgardie.

## BACKGROUND

Mr Trail has been the Chief Executive Officer of the Shire of Coolgardie for over 9 years. Mr Trail was suspended by Council from his role on the 14 November 2024 pending an investigation.

Although the investigation has not yet been completed, Mr Trail formally tendered his resignation in writing to the Shire President through his solicitors on 17 April 2025.

## COMMENT

This agenda item is presented to Council to endorse the Shire President accepting the resignation of Mr Trail from his role as the Chief Executive Officer effective as of the date of notice from the 17 April 2025 with the contract completion date being the 10 July 2025.

As the investigation is well advanced, it is incumbent on Council to allow it to continue to completion.
